



MEMORANDUM ORDER NO. 2013-22

AUTHORIZING THE CREATION AND FILLING-UP OF THE SENIOR DEPUTY ADMINISTRATOR AND AGENDA/MINUTES OFFICER I POSITIONS IN THE NATIONAL FOOD AUTHORITY (NFA).

WHEREAS, the Department of Agriculture (DA) has requested for the creation and filling-up of the Senior Deputy Administrator (SDA) position in the National Food Authority (NFA) to strengthen the external affairs of the NFA, such as coordination and communication with various government agencies, private entities and consuming public;

WHEREAS, the NFA has requested for the creation and filling-up of three (3) positions as support staff to the NFA Council Chairman to facilitate the proper discharge of the latter's duties and responsibilities;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, ...[and] implement the reorganization, merger or streamlining *unless otherwise directed by the President.*;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the creation and filling-up of the Senior Deputy Administrator (SG-29) position in NFA, in the latter's pursuit of its vital programs, specifically in food security, and in strengthening the latter's external affairs, as well as the creation and filling-up of an Agenda/Minutes Officer I (SG-11) position under the NFA Council Secretariat, to facilitate the administrative requirements of the NFA Council and allow them to properly discharge their duties and responsibilities;

NOW, Be it –

RESOLVED, the creation and filling-up of the following positions is hereby **APPROVED**:

RESOLVED FURTHER, that the authorization to hire the foregoing is **SUBJECT TO THE FOLLOWING**:

1. The Senior Deputy Administrator position shall be co-terminus with the Appointing Authority and shall be abolished once vacated;

2. Supplemental funds for the purpose shall be taken fully from the corporate funds of the NFA, as approved by its Governing Board, and no budgetary support will be provided by the National Government for personal services; and
3. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.
