



MEMORANDUM ORDER NO. 2013-30

AUTHORIZING THE EXTENSION OF SERVICE OF 18 EMPLOYEES IN THE LOCAL WATER UTILITIES ADMINISTRATION.

WHEREAS, the Local Water Utilities Administration (LWUA) requested for the authority to extend or renew the services of a total of eighteen (18) personnel, including those of four (4) casual personnel;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, ...[and] implement the reorganization, merger or streamlining unless otherwise directed by the President;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the renewal or extension of services of the said employees and in order to ensure the unhampered operations of LWUA while it undergoes wide-scale organizational change in the implementation of its Rationalization Plan under Executive Order No. 421;
