



**MEMORANDUM ORDER NO. 2013-36**

**AUTHORIZING THE METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM TO HIRE / RENEW THE SERVICES OF ELEVEN (11) CONSULTANTS.**

**WHEREAS**, the Metropolitan Waterworks Sewerage and System (MWSS) requested for the authority to hire / renew the services of eleven (11) consultants;

**WHEREAS**, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, ...[and] implement the reorganization, merger or streamlining unless otherwise directed by the President;

**WHEREAS**, under Section 53.7 of the Revised Implementing Rules and Regulations of R.A. No. 9184, "the term of the individual consultants or partnerships shall, at the most, be on a six (6) month basis, renewable at the option of the appointing Head of the Procuring Entity, but in no case shall exceed the term of the latter";

**WHEREAS**, the Commission has determined that it is in the best interest of the State and the public to allow MWSS in the latter's pursuit of its Water Security Legacy program, to hire / renew the services of eleven (11) consultants as enumerated hereunder;
