



MEMORANDUM ORDER NO. 2013-10.

**AUTHORIZING THE EMPLOYEES' COMPENSATION COMMISSION (ECC) TO
CREATE AND HIRE TWENTY-ONE (21) CASUAL POSITIONS AND
RECLASSIFY ITS EXISTING SIX (6) CASUAL POSITIONS.**

WHEREAS, the ECC has requested from the Department of Budget and Management (DBM) authority to create and hire twenty-one (21) casual positions and reclassify/upgrade six (6) casual positions previously approved by the DBM;

WHEREAS, the request is tantamount to an exemption from the hiring policies pending rationalization under E.O. No. 366, s. 2004, as ECC has yet to submit its Rationalization Plan following the withdrawal of its proposed RP in September 2009, through Board Resolution No. 09-08-108 dated 14 August 2009;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the ECC, in the latter's pursuit of its vital programs, to create and hire twenty-one (21) casual positions and reclassify six (6) casual positions, as enumerated hereunder;

NOW, BE IT –

RESOLVED, the request of the ECC to create and hire 21 casual positions is hereby **APPROVED**:
