



MEMORANDUM ORDER NO. 2015-10

AUTHORIZATION FOR THE METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM REGULATORY OFFICE TO FILL TEN (10) PLANTILLA POSITIONS

WHEREAS, MWSS-RO requested for authority to fill ten (10) plantilla positions in view of the recent personnel movements and in order to fulfill its performance commitments;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act (R.A.) No. 10149 mandates the GCG to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the MWSS-RO to fill ten (10) plantilla positions, as enumerated hereunder;

NOW, BE IT –

RESOLVED, that the request of the MWSS-RO is **APPROVED**, and it is hereby authorized to fill ten (10) plantilla positions, as follows:

RESOLVED FURTHER, that the authorization to fill and engage the aforementioned positions is **SUBJECT TO THE FOLLOWING**:

1. In case the ten (10) plantilla positions are excluded in the staffing pattern under the GCG-approved MWSS-RO Reorganization/Rationalization Plan (RP), appointees to said

positions shall exercise options available under E.O. No. 366 or other applicable laws and its Implementing Rules and Regulations;

2. Funds for the purpose shall be taken fully from the corporate funds of the MWSS-RO, included in its Corporate Operating Budget as approved by its Board of Trustees; and
3. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.
