



## MEMORANDUM ORDER NO. 2016-01

## AUTHORIZING THE PEOPLE'S TELEVISION NETWORK, INC. (PTNI) TO EXTEND THE SERVICES OF TWENTY TWO (22) CONTRACTUAL EMPLOYEES
