



## MEMORANDUM ORDER NO. 2024-19

### RECLASSIFICATION AND CONVERSION OF POSITIONS IN THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO)

**WHEREAS**, the Governance Commission for GOCCs (GCG), through Memorandum Order (M.O.) No. 2013-21 dated 01 April 2013, approved the Reorganization Plan of the PCSO with 158 organizational units and 1,726 positions;

**WHEREAS**, the PCSO Board of Directors in its Board Resolution No. 051, series of 2024, approved the reclassification of various positions in the corporation with reference to the Department of Budget and Management (DBM) National Budget Circular No. 521, series of 2009<sup>1</sup> and the Index of Occupational Services, Occupational Groups, Classes and Salary Grades (IOS);

**WHEREAS**, the GCG, pursuant to Section 5(a) of the Republic Act (R.A.) No. 10149, is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, ... [and] implement the reorganization, merger or streamlining unless otherwise directed by the President";

**WHEREAS**, the GCG has determined that it is in the best interest of the State and the public to approve, with modification, the PCSO's request for reclassification of positions;

**NOW**, Be it –

**RESOLVED**, that the GCG hereby **APPROVES WITH MODIFICATION** the request of the PCSO as follows:

- a. *Reclassification* of 18 plantilla positions under the Accounting and Budget Department, Branch Operations Sector, Medical Services Department, Charity Assistance Department, Office of the Assistant General Manager for Charity Sector, and Assets and Supply Management Department:
