



MEMORANDUM ORDER NO. 2023-10

**CHANGE IN REPORTING LINE AND SCRAP & BUILD OF POSITIONS
 IN THE CORPORATE IS/IT DIVISION OF THE NATIONAL
 TRANSMISSION CORPORATION (TRANSCO)**

WHEREAS, the GCG, through Memorandum Order No. 2018-06 dated 26 July 2018, approved the organizational strengthening of the National Transmission Corporation (TRANSCO);

WHEREAS, TRANSCO requested for authority from the GCG to implement operational flexibilities for the Change of Reporting Lines of the Corporate IS/IT Division (CISITD) and the Scrap and Build of positions in order to more effectively and efficiently respond to merging needs of the organization;

WHEREAS, pursuant to Section 5(a) of the “GOCC Governance Act of 2011” (R.A. No. 10149), the GCG is mandated to evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized;

WHEREAS, the GCG has determined that it is in the best interest of the State to implement such change in reporting line and create the requested position through Scrap and Build mentioned hereunder;

NOW, BE IT –

RESOLVED, that the request for the change in reporting lines of CISITD from Policy and Strategy Development Department (PSDD) to the Office of the Vice President, Resource Management Services Group (RMSG) is hereby **APPROVED**, *provided*, that such shall apply only during the tenure of TRANSCO Officer-in-Charge Dinna O. Dizon.

RESOLVED FURTHER, a Programmer III position is hereby **CREATED** through Scrap and Build as follows:
