



MEMORANDUM ORDER NO. 2024-06

AUTHORIZING PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) TO ABOLISH NINE HUNDRED TWENTY-NINE (929) PLANTILLA POSITIONS FOLLOWING THE TRANSITION OF CASINO FILIPINO – NEW COAST FROM A PAGCOR-OPERATED CASINO TO A LICENSED CASINO

WHEREAS, PAGCOR and Marina Square Properties, Inc. (MSPI) entered into a lease agreement on 14 March 2003 wherein it was agreed that MSPI would allow PAGCOR to use the gaming premises (inclusive of fittings and equipment) and office premises located within the Marina Plaza Hotel (now referred to as the *New Coast Hotel*), while PAGCOR would provide the manpower to operate the casino operations with a term of 12 years or from 31 March 2004 until 31 March 2016;

WHEREAS, a new lease agreement was signed on 18 December 2015 extending the lease term to 31 March 2031;

WHEREAS, Addendum 3 of the 2003 Lease Agreement states that PAGCOR "shall, and shall do all that is within its power, to grant an Authority to Operate to the Lessor or to a party nominated by the Lessor as a Third Party Casino Operator to operate the PAGCOR Casino at the Leased Premises on terms and conditions no less favourable than those granted by PAGCOR to existing or then existing Third Party Casino Operators…"

WHEREAS, in a letter to PAGCOR dated 09 May 2014, MSPI requested for a grant/issuance of an Authority to Operate (ATO) as third-party casino operator;

WHEREAS, following the Commission on Audit's recommendation, the lease agreement was renamed into a Memorandum of Agreement (MOA) and was signed on 09 August 2021 retaining the lease term of until 31 March 2031;

WHEREAS, the MOA includes a provision "Notwithstanding MSPI and PAGCOR relationship created under and by virtue of this Agreement, nothing prevents MSPI from applying for a license or authority to operate a casino from PAGCOR..."

WHEREAS, after a series of negotiations on the provisions of the contract, the Provisional License was officially executed on 27 September 2023 and agreed that the turnover of the casino premises to MSPI shall be implemented on 19 February 2024:

WHEREAS, to avoid redundancy in the workforce complement, PAGCOR, through a letter dated 11 January 2024, requested the abolition of the seven hundred seventy-four (774) plantilla positions affected by the transition of the Casino Filipino – New Coast from a PAGCOR-operated casino to a licensed casino;

WHEREAS, the Governance Commission for GOCCs (GCG), pursuant to Republic Act (R.A.) No. 10149 mandates the GCG to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be



reorganized, merged, streamlined, abolished, or privatized, in consultation with the department or agency to which a GOCC is attached;"

WHEREAS, upon review of the Governance Commission, it was found that there are nine hundred twenty-nine (929) plantilla positions under Casino Filipino – New Coast, 706 of which are filled as of 15 March 2024;

WHEREAS, the Governance Commission has determined that it is in the best interest of the State and the public to grant PAGCOR the authority to abolish the plantilla positions of Casino Filipino – New Coast;

NOW, BE IT -

RESOLVED, that the request of PAGCOR is **APPROVED**, and it is hereby authorized to abolish 929 plantilla positions specified as follows:

- 2. The pertinent civil service policies, budgetary, accounting, auditing, and other applicable rules and regulations shall be complied with; and
- 3. Any further modification/s on PAGCOR's Organizational Structure and Staffing Pattern is/are prohibited unless otherwise approved by the GCG.
