



MEMORANDUM ORDER NO. 2022-15

AUTHORIZING THE LANDBANK RESOURCES AND DEVELOPMENT CORPORATION (LBRDC) TO CREATE ONE (1) INFORMATION TECHNOLOGY ANALYST POSITION

WHEREAS, the Governance Commission for GOCCs (GCG), pursuant to Republic Act (R.A.) No. 10149, is mandated to “*evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, ...[and] implement the reorganization, merger, or streamlining unless otherwise directed by the President*”;

WHEREAS, the LBRDC currently has no Information Technology (IT) position;

WHEREAS, LBRDC represented that in view of its continuous expansion of business transactions, there is an immediate need for an IT Specialist who will handle all IT concerns of the company that include but not limited to troubleshooting, support, and repair;

WHEREAS, the LBRDC Board of Directors, thru Board Resolution No. 21-02-08, approved the creation of the Information Technology Specialist position;

WHEREAS, the LBRDC clarified that under its position classification system, the position is assigned with a Pay Grade of 5;

WHEREAS, the GCG determined that it is in the best interest of the State and the public to create a position to support the continued expansion of LBRDC and to promote better, effective, and efficient services to the public;

NOW, Be it –

RESOLVED, the creation of one (1) Information Technology Specialist is hereby **APPROVED WITH MODIFICATION** as follows:

RESOLVED FINALLY, that this authorization is **SUBJECT TO THE FOLLOWING CONDITIONS**:

1. Funds for the purpose of filling up shall be taken fully from the corporate funds of the LBRDC and included in its approved Corporate Operating Budget (COB) as approved by its Governing Board;

“Upholding a Transparent and Responsive GOCC Sector for the Filipino People”


2. Any modification/s to the existing organizational structure and staffing pattern of the LBRDC is/are prohibited unless otherwise approved by the GCG; and
