Description

1. The Governance Commission for GOCCs (GCG) through the F.Y. 2023 General Appropriations Act (GAA) intends to apply the sum of Three Million Pesos Only (₱3,000,000.00), being the ABC, to payments under the contract for the procurement of One (1) Lot Annual Maintenance and Support Services for the existing GCG – Hyperconverged Infrastructure System Solution (P.R. No. 23-0027). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The GCG now invites bids for the above Procurement Project. The delivery of required renewal of annual maintenance agreement subscription must be completed within thirty (30) calendar days from the receipt of the Notice to Proceed. The bidder must have completed a similar contract for Renewal of Nutanix Maintenance and Support Services Agreement for the past three (3) years from the date of submission and receipt of bids. Also, the bidder shall be subjected to evaluation by the end-user after the implementation of the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the GCG office and inspect the Bidding Documents at the address given below during the hours of 8:00am to 3:00pm, Mondays to Fridays.

5. 5. A complete set of Bidding Documents may be acquired by interested Bidders on 10 July 2023 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (₱5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means provided that the presentation of the same be done before the scheduled bid opening.
