

MEMORANDUM ORDER NO. 2012-17

AUTHORIZING THE PEOPLE'S TELEVISION NETWORK, INC. (PTNI) TO EXTEND THE SERVICES OF ONE (1) TEMPORARY EMPLOYEE AND TWENTY FIVE (25) CONTRACTUAL EMPLOYEES

WHEREAS, the PEOPLE'S TELEVISION NETWORK, INC. (PTNI) has requested for authority to extend the services of twenty six (26) temporary and casual employees as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s.2004;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) mandates the GCG to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached":

WHEREAS, the Department of Budget and Management (DBM) evaluated and subsequently recommended that PTNI's request to extend the services of one (1) temporary employee and twenty five (25) contractual employees be extended;

WHEREAS, the Commission has likewise determined that it is in the best interest of the State and the public to allow PTNI, as the primary authority to identify its needs as a GOCC to extend the services of one (1) temporary employee and twenty five (25) contractual employees as enumerated hereunder;

- c. The pertinent civil service, budgetary, accounting, auditing, and other applicable laws, rules and regulations shall be complied with."
