QUERY	REMARKS
Referring to Item 4.2.1 of the Terms of Reference, is it possible to modify the manpower requirement “with each personnel being a regular employee of the bidder” to “with each personnel being a regular employee of the bidder or bidder’s product distributor or product principal”? Would the GCG allow outsourced personnel instead of a regular employee of the bidder?	No, the requirement on 4.2.1 will be retained.
Since the pre-bid conference was rescheduled, does the deadline for the submission and opening of bids will also be rescheduled?	The schedule for the deadline of submission and opening of bids remains the same which will be on 19 September 2024, 10:00 AM.

Bidders are only required to submit the same during post-qualification for the Technical Working Group’s verification. ➤ For the statement of all its ongoing and completed government and private contracts, there is no need to attach a copy of each of the contract enumerated in the statement.
