



MEMORANDUM ORDER NO. 2014-09

AUTHORIZATION FOR THE METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM REGULATORY OFFICE (MWSS-RO) TO FILL EIGHT (8) REGULAR PLANTILLA POSITIONS

WHEREAS, MWSS-RO requested for authority to fill-up eight (8) vacant regular plantilla positions as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s.2004;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act (R.A.) No. 10149 mandates the GCG to “evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached”;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the MWSS-RO to fill-up the eight (8) positions, as enumerated hereunder;

NOW, BE IT –

RESOLVED, that the request of the MWSS-RO is **APPROVED**, and it is hereby authorized to fill-up eight (8) regular plantilla positions, as follows:

RESOLVED FURTHER, that the authorization to fill-up the aforementioned positions is **SUBJECT TO THE FOLLOWING**:

1. In case the eight (8) regular positions are excluded in the staffing pattern under the approved MWSS-RO Rationalization Plan (RP), appointees to said positions shall exercise options available under E.O. No. 366 and its Implementing Rules and Regulations;
2. Funds for the purpose shall be taken fully from the corporate funds of the MWSS-RO, included in its Corporate Operating Budget as approved by its Board of Trustees; and

3. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.


