



MEMORANDUM ORDER NO. 2016-11

AUTHORIZATION FOR THE METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM REGULATORY OFFICE TO FILL FIVE (5) VACANT POSITIONS

WHEREAS, MWSS-RO requested for authority to fill five (5) the following positions;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act (R.A.) No. 10149 mandates the GCG to “evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached”;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the MWSS-RO to fill a total of five (5) positions under the Tariff Control and Monitoring Department, Operations Monitoring Department, Public Information Department, Administration Department and Complaints Services Monitoring Department;

2. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.


