



**MEMORANDUM ORDER NO. 2021-03**

**RETITLING / CONVERSION OF POSITIONS IN MWSS-RO**

**WHEREAS**, the Metropolitan Waterworks and Sewerage System – Regulatory Office (MWSS-RO) requested approval to retitle five (5) Supervising Water Utilities Regulation Officer (WURO) positions and nine (9) Senior Water Utilities Regulation Officer (SWURO) positions to Supervising Public Utilities Regulation Officer (PURO) and Senior Public Utilities Regulation Officer (SPURO), respectively, as contained in the CSC Qualification Standards Manual (1997);

**WHEREAS**, the Governance Commission for GOCCs (GCG) pursuant to Republic Act (R.A.) No. 10149 is mandated to “evaluate and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized... [and] implement [the restructuring] *unless otherwise directed by the President.*”
