Description

- 1. In view of two (2) failed biddings, the GOVERNANCE COMMISSION FOR GOCCs (GCG) invites capable suppliers to participate in the negotiation for the Procurement of Supply and Delivery of Brand-New Vehicles for GCG's Refleeting Program (P.R. No. 23-0036).
- 2. The GCG, through the General Appropriations Act of 2023, intends to apply the sum of Five Million Eight Hundred Ten Thousand Pesos Only (₱5,810,000.00), being the Approved Budget for the Contract (ABC) to payments under the contract for the abovementioned procurement. Proposals received in excess of the ABC shall be automatically rejected at the opening of the financial proposals. The GCG invites PhilGEPS registered suppliers to bid any of the following items:

- 3. Pursuant to Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. No. 9184, we invite legally, technically and financially capable suppliers to negotiate for the project through the Negotiation Conference to be held on 22 January 2024 at 10:00AM at 3/F, BDO Towers Paseo, 8741 Paseo de Roxas, Makati City, Philippines 1226 and/or through video conferencing or webcasting via Microsoft Teams which shall be open to prospective suppliers. Prospective bidders that intend to participate through video conferencing may confirm their

attendance by sending their email address to procurement@gcg.gov.ph to receive the meeting invitation.

- 4. Negotiation is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 5. Following the completion of the negotiations, the best and final offer based on the technical and financial requirements, including the pre-requisite documentary requirements enumerated in the checklist of requirements hereof must be duly received by the BAC Secretariat on or before 29 January 2024 at 10:00AM, at 3/F, BDO Towers Paseo, 8741 Paseo de Roxas, Makati City, Philippines 1226. Late submissions shall not be accepted.
- 6. The GCG reserves the right to reject any and all proposals, declare a failure of negotiation or procurement, or not award the contract at any time prior to contract award in accordance with Section 41 of R.A. No. 9184 and its Revised IRR, without thereby incurring any liability to the affected bidder or bidders.
