



## **MEMORANDUM ORDER NO. 2013-39**

### **AUTHORIZING THE PHILIPPINE PORTS AUTHORITY (PPA) TO FILL TEN (10) PLANTILLA POSITIONS.**

**WHEREAS**, PPA, through a letter dated 27 August 2013, requested for authority to fill ten (10) plantilla positions as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s.2004;

**WHEREAS**, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) mandates the GCG to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

**WHEREAS**, the Commission has determined that it is in the best interest of the State and the public to allow the PPA, in the latter's pursuit of its vital programs, to fill the 10 plantilla positions as described hereunder;

2. Funds for the purpose shall be taken fully from the corporate funds of PPA, included in its Corporate Operating Budget as approved by its Board of Directors, and no budgetary support will be provided by the National Government for personal services; and
3. The pertinent civil service policies, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.
