

MEMORANDUM ORDER NO. 2013-39

AUTHORIZING THE PHILIPPINE PORTS AUTHORITY (PPA) TO FILL TEN (10) PLANTILLA POSITIONS.

WHEREAS, PPA, through a letter dated 27 August 2013, requested for authority to fill ten (10) plantilla positions as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s.2004;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) mandates the GCG to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the PPA, in the latter's pursuit of its vital programs, to fill the 10 plantilla positions as described hereunder;

- 3. The pertinent civil service policies, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.
