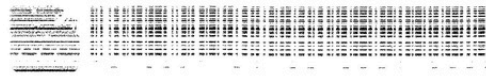
Dear Ms. Pinili,

This is to inform you that the undersigned has approved Resolution No. 24-0082-01 of the Bids and Awards Committee (BAC), recommending the award of the contract for the procurement of the above-mentioned project to **DRIZ GLOBAL TRADING OPC** in the amount of **TWO HUNDRED NINETY-NINE THOUSAND PESOS ONLY (P299,000.00)**.

Pursuant to Sections 39.1 and 39.2 of the 2016 Revised IRR of R.A. c. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.	₱89,700.00 or thirty percent (30%) of ₱299,000.00.
