



## MEMORANDUM ORDER NO. 2012-05

### AUTHORIZING THE MANILA INTERNATIONAL AIRPORT AUTHORITY (MIAA) TO CREATE AND FILL THIRTY-FOUR (34) CONTRACTUAL POSITIONS AND TO FILL FOUR (4) CASUAL POSITIONS.

**WHEREAS**, MIAA has requested for authority to create and fill thirty-eight (38) contractual positions and to fill five (5) casual positions as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s.2004;

**WHEREAS**, the DBM, after conducting its evaluation, has recommended to allow MIAA to create and fill only thirty-four (34) contractual positions and to fill only four (4) casual positions;

**WHEREAS**, the Governance Commission for GOCCs (GCG), pursuant to Republic Act No. 10149 (R.A. No. 10149), is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

**WHEREAS**, the Commission, taking into account MIAA's capacity to improve its operational needs as a GOCC, in addition to the evaluation and recommendation of the DBM, has determined that it is in the best interest of the State to allow MIAA to create and fill thirty-four (34) contractual positions and to fill four (4) casual positions as enumerated hereunder;

**WHEREAS**, a Memorandum has been submitted by the Commission to the President informing His Excellency of the said determination and the Commission has not received any directive otherwise;

**NOW**, Be it –

**RESOLVED**, that the request of MIAA is **PARTIALLY APPROVED**, and it is hereby authorized to create and fill thirty-four (34) contractual positions and to fill four (4) casual positions, as follows:

**RESOLVED FURTHER**, that the authorization to create and/or fill the foregoing positions is **SUBJECT TO THE FOLLOWING**:

1. Extension of hiring contractual and casual personnel for the Ramp Control Service (RCS) shall be subject to the annual evaluation, review, and recommendation by the DBM;
2. Funds for the purpose shall be taken fully from corporate funds of the MIAA, which shall be included in its annual Corporate Operating Budget as approved by its Board of Directors; and
3. The pertinent civil service, budgetary, accounting, auditing, and other applicable laws, rules and regulations shall be complied with.
