**MEMORANDUM ORDER NO. 2024-20**

**APPROVING THE CREATION OF LENDING CENTERS, TRANSFER OF REPORTING LINES, AND ORGANIZATIONAL REALIGNMENT IN LAND BANK OF THE PHILIPPINES (LANDBANK)**

**WHEREAS**, the Governance Commission for GOCCs (GCG) approved the organizational structure and staffing pattern (OSSP) of LANDBANK as part of its Restructuring Plan through Memorandum Order (M.O.) No. 2023-04;

**WHEREAS**, the Land Bank of the Philippines (LANDBANK) Board of Directors in its Resolution Nos. 22-670, 22-810, 22-812, 23-015, 23-124, 23-194, 23-461, 23-195, 23-392, 23-461 and 23-463 approved and confirmed the following: creation of Negros Occidental North Lending Center (NONLC) and Negros Occidental South Lending Center (NOSLC), and splitting of Nueva Ecija Lending Center (NELC) into North Nueva Ecija Lending Center (NNELC) and South Nueva Ecija Lending Center (SNELC); change in reporting line of the Credit Card Administration Department (CCAD), Corporate Affairs Group, and Security Department (SD); and organizational changes in the Trust Banking Group (TBG), Corporate Banking Department II (CBD II), Organizational Development Department (ODD), ATM Operations Support Department (AOSD), and Cash Operations Support Department (COSD).

**WHEREAS**, the GCG, pursuant to Republic Act (R.A.) No. 10149, is mandated to “evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, ...[and] implement the reorganization, merger or streamlining unless otherwise directed by the President”;

**WHEREAS**, the GCG determined that it is in the best interest of the State and the public to approve the organizational changes in LANDBANK;

**NOW**, Be it –

**RESOLVED**, that the GCG hereby **APPROVES WITH MODIFICATION** the creation of additional Lending Centers, transfer of reporting lines, and organizational changes of various organizational units in LANDBANK as reflected in the attached staffing pattern (***Annex A***);

**RESOLVED FINALLY**, the foregoing is **SUBJECT TO THE FOLLOWING CONDITIONS** as follows:

- a. Funding requirements for regular positions shall be included in the Corporate Operating Budget of LANDBANK;
- b. The pertinent budgetary, accounting, auditing, civil service and other applicable laws, rules and regulations shall be complied with; and



c. Any further modification/s on LANDBANK's OSSP is/are prohibited unless otherwise approved by the GCG.
