



MEMORANDUM ORDER NO. 2013-23

AUTHORIZING THE EMPLOYEES' COMPENSATION COMMISSION (ECC) TO FILL SIXTEEN (16) REGULAR PLANTILLA POSITIONS

WHEREAS, the ECC has requested for authority to fill sixteen (16) regular plantilla positions, as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s. 2004 and its Implementing Rules and Regulations (IRR);

WHEREAS, ECC has yet to submit its Rationalization Plan following the withdrawal of its proposed RP in September 2009 through Board Resolution No. 09-08-108 dated 14 August 2009;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

WHEREAS, the Commission has adopted the policy that while undergoing rationalization, the grant of authority to fill particular plantilla items continue until the Rationalization Plan (RP) is approved since by virtue of such grant the said items have already been deemed necessary and highly unlikely to be abolished;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the ECC, in the latter's pursuit of its vital programs, to fill sixteen (16) regular plantilla positions, as enumerated hereunder;

NOW, BE IT –

RESOLVED, the request of the ECC to fill 16 regular plantilla positions is hereby **APPROVED** as follows:

RESOLVED FURTHER, that the authorization to fill up the abovementioned position is **SUBJECT TO THE FOLLOWING**:


- a. In case the above positions are excluded in the staffing pattern under the approved ECC RP, the appointees to these positions shall exercise the options available under E.O. No. 366;

- c. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.
