



MEMORANDUM ORDER NO. 2014-01

AUTHORIZING THE PEOPLE'S TELEVISION NETWORK, INC. (PTNI) TO EXTEND THE SERVICES OF ONE (1) TEMPORARY EMPLOYEE AND TWENTY THREE (23) CONTRACTUAL EMPLOYEES

WHEREAS, the PEOPLE'S TELEVISION NETWORK, INC. (PTNI) has requested for authority to extend the services of one (1) temporary employee and twenty three (23) contractual employees;

WHEREAS, the Governance Commission for GOCCs (GCG), pursuant to Republic Act (R.A.) No.10149, is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department or agency to which a GOCC is attached";

WHEREAS, the Board of Directors of PTNI has yet to exercise its power under Section 18 of R.A. No. 10390 to reorganize the Network to make it more effective and innovative, subject to the provisions of R.A. No. 10149;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow PTNI, as the primary authority to identify its needs as a GOCC, to extend the services of one (1) temporary employee and twenty three (23) contractual employees as enumerated hereunder;

RESOLVED FURTHER, that the foregoing authorization is **SUBJECT TO THE FOLLOWING CONDITIONS**:

- a. The effectivity of the contract shall not go beyond one (1) month after the approval of the agency's Reorganization Plan, or 30 June 2014, whichever comes first;
- b. Funds for this purpose shall be charged against internally-generated corporate funds/project funds included in the PTNI Board-approved Corporate Operating Budget;
- c. The maximum number of personnel whose contracts/appointments would be renewed shall not exceed the actual employees at the start of the PTNI's reorganization efforts, as adjusted by the GCG-authorized hiring of new/additional personnel;
- d. There shall be no new hiring and/or replacement of resigned/retired/separated/terminated/regularized staff; and
- e. The pertinent civil service, budgetary, accounting, auditing, and other applicable laws, rules and regulations shall be complied with.
