



MEMORANDUM ORDER NO. 2012-28

AUTHORIZING THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA) TO FILL TWENTY-ONE (21) PLANTILLA POSITIONS

WHEREAS, TIEZA has requested from the Department of Budget and Management (DBM) exemption from the continuing moratorium on the filling of vacant regular/permanent/itemized positions per DBM CL No. 2011-14 dated 22 December 2011 and requested *authority to fill 21 permanent positions under the Philippine Tourism Authority (PTA) Plantilla* pending approval by the DBM (now with the GCG) of TIEZA's proposed Organizational Structure and Staffing Pattern (OSSP) pursuant to Section 25 of Republic Act (R.A.) No. 9593 or the Tourism Act of 2009 wherein the PTA was reorganized as TIEZA and as such is mandated to rationalize its functions;

WHEREAS, under Section 73 of R.A. No. 9593, TIEZA is mandated as the principal agency responsible for the timely collections and allocation of travel taxes and as such, the filling up of the positions of Travel Tax Officers, Cashiers, Accounts Analyst and Clerk Processor are therefore deemed necessary for TIEZA to effectively perform its functions.

WHEREAS, the Governance Commission for GOCCs (GCG), pursuant to R.A. No. 10149 is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

WHEREAS, the Commission concurred with the DBM recommendation and has further determined that it is in the best interest of the State to allow TIEZA, as the primary authority to identify its needs as a GOCC, to fill-up 21 permanent plantilla positions as enumerated hereunder;

NOW, BE IT –

RESOLVED, the request of the TIEZA to fill-up the following positions is hereby **APPROVED**:

RESOLVED FURTHER, that the authorization to fill-up the foregoing positions is **SUBJECT TO THE FOLLOWING**:

1. In case the above positions are excluded in the staffing pattern under the approved TIEZA Reorganization Structure, the appointees to these positions shall exercise the options available under Section 27 of R.A. No. 9593;
2. Funds for the purpose shall be taken fully from the corporate funds of TIEZA, included in its Corporate Operating Budget as approved by its Board of Directors, and
3. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.
