



**MEMORANDUM ORDER NO. 2013- 31**

**AUTHORIZING THE MACTAN CEBU INTERNATIONAL AIRPORT  
AUTHORITY (MCIAA) TO FILL SIX (6) TERMINAL OPERATIONS  
ASSISTANT A POSITIONS.**

**WHEREAS**, the MCIAA has requested for authority to fill six (6) Terminal Operations Assistant A (SG-10) positions as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s.2004, and DBM Circular Letter Nos. 2012-20;

**WHEREAS**, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached";

**WHEREAS**, the Commission has determined that it is in the best interest of the State and the public to allow the MCIAA, in the latter's pursuit of its vital programs, to fill six (6) Terminal Operations Assistant A positions, as enumerated hereunder;

options available under E.O. 366 and its Implementing Rules and Regulations;

2. Funds for the purpose shall be taken fully from the corporate funds MCIAA's CY 2013 Corporate Operating Budget as approved by its Board of Trustees, and no budgetary support will be provided by the national government for personal services; and
3. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.




