



MEMORANDUM ORDER NO. 2013-17

APPROVAL OF THE REORGANIZATION PLAN (RP) OF THE METROPOLITAN WATERWORKS SYSTEM – CORPORATE OFFICE (MWSS-CO)

WHEREAS, MWSS is an engineering project-based organization with a primary purpose to develop and maintain waterworks system within its jurisdiction particularly in Metro Manila;

WHEREAS, in 2011, MWSS created a Water Security Legacy Program (WSLP) for the benefit of 15 Million Metro Manila residents and aims to execute ₱80 billion waterworks engineering projects;

WHEREAS, the MWSS-CO has requested for approval of its Reorganization Plan (RP) with a total of one hundred forty (140) permanent positions;

WHEREAS, Section 5(a) of Republic Act No. 10149 (R.A. No. 10149) mandates the Governance Commission for GOCCs (GCG) to “evaluate and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department or agency to which a GOCC is attached... [and] implement [the restructuring] *unless otherwise directed by the President.*”;

WHEREAS, the Commission has determined that it is in the best interest of the State to approve the MWSS RP with certain modifications, in the latter’s pursuit of its vital programs and objectives;

NOW, BE IT –

RESOLVED, that the Reorganization Plan of MWSS, as summarized in **Annex “A”** hereof, is hereby **APPROVED**;

RESOLVED FURTHER, that the Reorganized Table of Organization of MWSS as indicated in **Annex “B”** hereof, reflects the following number of organizational units:


