



MEMORANDUM ORDER NO. 2013-15

AUTHORIZING THE CLARK INTERNATIONAL AIRPORT CORPORATION (CIAC) TO FILL TWENTY-SIX (26) PLANTILLA POSITIONS.

WHEREAS, CIAC has requested for authority to fill twenty-six (26) plantilla positions as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s. 2004;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) mandates the GCG to “evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached”;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the CIAC, in the latter’s pursuit of its vital programs, to fill the positions as described hereunder;
