

MEMORANDUM ORDER NO. 2013-12.

AUTHORIZING THE OCCUPATIONAL SAFETY AND HEALTH CENTER (OHSC) TO CREATE AND FILL SEVENTEEN (17) CONTRACTUAL POSITIONS

WHEREAS, the OHSC has requested from the Department of Budget and Management (DBM) authority to create and fill seventeen (17) contractual positions;

WHEREAS, the request is tantamount to an exemption from the hiring policies pending rationalization under E.O. No. 366, s. 2004, as OSHC has yet to submit its Rationalization Plan following the withdrawal of its proposed RP in September 2009 through Board Resolution No. 09-08-108 dated 14 August 2009;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to "evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department or agency to which a GOCC is attached";

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the OSHC, in the latter's pursuit of its vital programs, to create and fill seventeen (17) contractual positions, as enumerated hereunder;

NOW, BE IT -

RESOLVED, the request of the OSHC to create and fill 17 contractual positions is hereby **APPROVED** as follows:

- Funds for the purposes shall be taken fully from the corporate funds of the OSHC, which shall be included in its annual Corporate Operating Budget as approved by its Board of Directors; and
