



MEMORANDUM ORDER NO. 2013-11

AUTHORIZING THE MACTAN-CEBU INTERNATIONAL AIRPORT AUTHORITY (MCIAA) TO FILL TWENTY-FOUR (24) REGULAR PLANTILLA POSITIONS.

WHEREAS, the MCIAA has requested for authority to fill thirty-one (31) regular plantilla positions as an exemption from the pertinent provisions of Executive Order (E.O.) No. 366, s.2004, and DBM Circular Letter Nos. 2009-13 and 2011-14;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act No. 10149 (R.A. No. 10149) is mandated to “evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached”;

WHEREAS, the Commission has determined that it is in the best interest of the State and the public to allow the MCIAA, in the latter’s pursuit of its vital programs, to fill twenty-four (24) positions, out of the total 31 positions initially requested, as enumerated hereunder;
