



**MEMORANDUM ORDER NO. 2017-08**

**CREATION OF ONE HUNDRED THIRTY-SIX (136)  
 COMMUNICATION, NAVIGATION, AND SURVEILLANCE SYSTEMS OFFICER I  
 (CNSSO-I) POSITIONS UNDER THE AIR NAVIGATION SERVICE (ANS) OF THE  
 CIVIL AVIATION AUTHORITY OF THE PHILIPPINES**

**WHEREAS**, CAAP requested for authority to create additional CNSSO-I positions in view of the urgent need to have qualified, competent and accountable CNSSO who have undergone comprehensive trainings for the implementation of the Communications, Navigation, Surveillance/ Air Traffic Management System (CNS/ATM Project) but are still under individual temporary job order (JO) service contracts, and in order to maintain its responsibility for the establishment, functional operation and safe and reliable management of Philippine air navigation systems;

**WHEREAS**, Republic Act (R.A.) No. 10149 mandates the Governance Commission for GOCCs (GCG) to “evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, in consultation with the department of agency to which a GOCC is attached”;

**WHEREAS**, the Commission has determined that it is in the best interest of the State and the public to grant CAAP the authority to create one hundred thirty-six (136) CNSSO-I positions as specified hereunder;

**NOW**, Be it –

**RESOLVED**, that the request of CAAP for additional plantilla positions is **APPROVED**, and 136 CNSSO-I positions are hereby created as follows:
